In about 1500 words define the concepts of professionalism and dual professionalism in education and training.

Review key features and benefits of an inclusive learning environment and the impact of personal, social, cultural factors, different cognitive, physical, and sensory abilities on learning.

Analyse your role and responsibilities as a teacher. As part of your response discuss your inclusive practice and analyse the relationships and boundaries between the teaching role, other professional roles and review strategies for effective liaison.

How do social, political and economic factors influence education policy? As part of your response analyse the impact of current educational policies on curriculum and practice in area of specialism. Explain the role and impact of external bodies and stakeholders on educational providers and practitioners?

Please write in brief how you plan to address the requirements of the

Discuss the concepts of professionalism within the realms of education, referring to ETF Professional Standards. Use sources to evidence the need for professionalism and the implications of standards on practice.

Introduce inclusive learning as it is a common theme to the standards and discuss how inclusivity can be addressed and embedded within education. Discuss barriers such as funding, support, prejudice.

Look at my role, include SpLd recognition, signposting and supporting. Identify the different role I have to other roles within the establishment and how we work together to ensure a successful outcome. Mention the lack of understanding of roles between departments.

Look at the difference in education providers, how politics, economy, and curriculum reforms impact on teachers and learners. Discuss my particular role within the organisation I work for. Explain how my delivery is governed by stakeholders and policies.

Good response regarding boundaries. Ensure you fully address the strategy of effective partnerships. Please give examples from current affairs regarding factors influencing educational policy. Consider the role of apprenticeships, free schools and academies. End by identifying the stakeholders and explaining their influence. I look forward to receiving your completed assignment.
